COUNT 2 - TAMPERING WITH PHYSICAL EVIDENCE

RE-INDICTMENT

IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:

THE GRAND JURY for the County of Midland, State of Texas, duly selected, impaneled, sworn, charged and organized as such by the 142nd JUDICIAL DISTRICT COURT for the said County at the JULY Term, A.D. 2025 of the said Court, upon their oaths present in and to said Court that MARIO JUAN CHACON, hereinafter styled Defendant, on or about 11th day of May, 2023, and before the presentment of this indictment, in the County and State aforesaid, did then and there intentionally and knowingly cause the death of an individual, Madeline Pantoja, by then and there kicking the said Madeline Pantoja with his foot, and by hitting and striking the said Madeline Pantoja with his hand and hands, and by hitting and striking the said Madeline Pantoja with an instrument to the Grand Jury unknown, and by strangling the said Madeline Pantoja with his hand and hands, and by strangling the said Madeline Pantoja with an instrument to the Grand Jury unknown, and by suffocating the said Madeline Pantoja

with an instrument to the Grand Jury unknown, and by a manner and means to the Grand Jury unknown,

Count I, Paragraph 2

AND THE GRAND JURORS AFORESAID, upon their oaths, do further present in and to said Court that the Defendant, on or about the 11TH DAY OF MAY, 2023, and before the presentment of this indictment, in the County of Midland, State of Texas intending to cause serious bodily injury to an individual Madeline Pantoja, did then and there commit an act clearly dangerous to human, to wit: did then and there kick the said Madeline Pantoja with his foot, and hit and strike the said Madeline Pantoja with his hand and hands, and hit and strike the said Madeline Pantoja with an instrument to the Grand Jury unknown, and strangle the said Madeline Pantoja with his hand and hands, and strangle the said Madeline Pantoja with an instrument to the Grand Jury unknown, and suffocate the said Madeline Pantoja with an instrument to the Grand Jury unknown, and an act to the Grand Jury unknown, thereby causing the death of the said Madeline Pantoja,

Count II

AND THE GRAND JURORS AFORESAID, upon their oaths, do further present in and to said Court that the Defendant, on or about the 11TH DAY OF MAY, 2023 and before the presentment of this indictment in the County of Midland, State of Texas did then and there, knowing that an offense had been committed, namely Murder,

conceal a human corpse, namely Madeline Pantoja's body, with intent to impair its availability as evidence in any subsequent investigation or official proceeding related to the offense.
